#### BACKGROUND

Human Rights Day is observed by the international community every year on 10 December. It commemorates the day on which the United Nations General Assembly adopted the Universal Declaration of Human Rights (UDHR), a milestone document that proclaimed the inalienable rights which everyone is inherently entitled to as a human being -- regardless of race, colour, religion, sex, language, political or other opinion, national or social origin, property, birth or other status.



Drafted by representatives of diverse legal and cultural backgrounds from all regions of the world, the Declaration sets out universal values and a common standard of achievement for all peoples and all nations. It establishes the equal dignity and worth of every person. Thanks to the Declaration, and States' commitments to its principles, the dignity of millions has been uplifted and the foundation for a more just world has been laid.

10 December also marks the formal inception of Human Rights Day since 1950, with the passing of resolution 423 (V) by the General Assembly.

#### THEME

This year's theme "Recover Better" is apt as the world is facing the dire impact of Covid-19. Discussions at this year's Forum will focus on the various challenges faced by different actors in the face of Covid-19, weigh the dimensions of human rights vs recovery and preserving life, as well as explore best practices in moving ahead and rebuilding together.

#### **OBJECTIVE**

The Human Rights Forum aims to:

- 1. Promote public awareness and support for human rights, and the work of various actors dedicated to promoting human rights, especially amongst youth;
- 2. Promote the spirit of cooperation and dialogue between various stakeholders, particularly the Government, National Human Rights Institution, academia, private sector and civil society; and
- 3. Provide an avenue for panelists from different fields to propose ideas on best practices, with the view of bringing improvement to the existing laws and regulations, as well as the structures and system related to the protection of human rights in the country.

## COVID-19

International human rights standards can strengthen the effectiveness of our interventions. It brings attention to people often left behind, such as persons with disabilities; indigenous peoples; migrants, refugees and internally displaced people; and, in particular, older people. People living in institutions, including many older people and people deprived of their liberty, are more vulnerable to this infection.

As noted by the UN High Commissioner for Human Rights during her recent briefing to the Human Rights Council, in every stage of this epidemic – including the recovery – it is imperative to involve National Human Rights Institutions, as well as civil society and human rights defenders.
